**TIME:** 9:00AM Both Days.

**Location:** Phoenix Rod & Gun Club, 915 West Olney Drive, Phoenix, AZ

**Eligibility:**

**NRA:** membership is not required to compete in this match. Non-NRA members cannot set National Records All competitors must be current members of the Arizona State Rifle & Pistol Association. If you are not a current member, please include annual dues of \$20.00 for adults or \$5.00 for juniors. Non-members may elect to pay a \$5.00 surcharge for this match in lieu of ASRPA membership. Non-Resident competitors are eligible for all awards including Arizona State Champion.

**Rules:** Current NRA SmallBore Rifle Rules will govern this tournament. The rifle permitted is defined in rule 3.2. Sights are defined under rule 3.7. Competitors will hang their own targets and retrieve their OWN target's. Competitors will identify their targets and backers in the upper right hand corner of the front face of each sheet with their competitor number & correct and complete match information.

Note: F-Class competitors will also add this on the Targets. **F-Class**

**Time: Firing will commence at 9:00 a.m. on Saturday & Sunday.**

**Squadding: All matches will be squadded.**

Competitors may be required to score. Any competitor failing to perform Scoring duties may be disqualified.

Note: To Help Alleviate the SUN bleeding thru on the target BULL's ALL competitors are given the Right to Place another Backer behind the TARGET.

**Challenges:** A fee of \$2.00 dollars will be charged for each challenge.

**Competitors:** Competitors must furnish their own target-mounting clips and will hang their own unfired targets.

**Classification:** NRA Conventional SmallBore Prone Classification will be used. Rule 19.6 "Assigned Classification" or 19.2 - Temporary Classification may be Used. Those unclassified or without proof of classification will be required to Compete in the Master class.

**Firing Time:** Firing will begin at 9:00 AM. Time limits for firing and changing Targets follow NRA rules.

**Course of Fire:** F-Class will be using A51, A50 & A33 Targets.
