**Categories / Classes**: The NRA Classification system will be used. Separate class awards will be given in each of two Categories: Civilian and Service. Members of the active Army, Navy, Marine Corps, Coast Guard, Air Force, National Guard, and Reserve components will make up the Service Category. Members of Federal, State, County, Municipal law enforcement groups and Industrial Police are also included in the Service Category. All others will be considered Civilians (Rule 2.2).

- 1. If there are less than five entries in any category within a class, they will be combined with other entries in another category within the same class.
- 2. If there are less than five entries after combining all categories of a class, there will be NO AWARDS provided in that class and all competitors in the lower class will be moved to their respective category in the next higher class.
- 3. If the five-competitor minimum required for award purposes has still not been fulfilled, competitors will be moved up in class and category until there are five or more in a class and category.
- 4. A class or category will not be combined downward. If there are less than five High Masters, they will compete for MATCH WINNER only.

# Awards:

Cash awards will be issued to shooters for matches and aggregate matches by class and category.
