This Agreement is between the Member and the Practical Division and is subject to the following terms.

1. A key MAY be issued after the Member has demonstrated the required degree of safety in the use of a firearm in the practical shooting environment, demonstrated a level of participation in the Practical Division (See Appendix A for the methods used in determining this requirement) and after receiving a range orientation from the Division Director or his/her designee. Issuance of a key is at the Division Director's discretion.

2. To retain your key, you are required to help maintain the Practical Range by participating in a minimum of 2 work events per year organized by the Division Director. You must notify the Division Director of the dates of your participation so he/she can complete the below. Match Directors, regular setup help and appointed Staff are exempt from this requirement.

3. The Member is responsible for the use of his/her key and agrees not to allow it's use by anyone other than the Member and to surrender the key to the Practical Division Director or his/her designee upon request.

4. The Member is responsible for adhering to the Practical Division Range Rules, as revised.

5. The Member is responsible for safety while on the range. This includes correcting someone else regarding safety or abusing range equipment. Any unsafe act or disregarding the terms of this Agreement or Club By-Laws may result in the cancellation of this Agreement and surrender of your key.

Statement of Acknowledgement:

I agree to abide by the terms of this Agreement. I also understand that this Agreement is revocable at any time and agree to surrender the key at the request of the Division Director or his/her designee. I understand that I may appeal the revocation of this Agreement to the PRGC Board of Directors but agree to surrender the key pending the outcome of the appeal. By signing below, I acknowledge that I have read and understand this Agreement; that I have received a copy of the Practical Division Range Rules, as revised; and that I have received a range orientation from the Practical Division Director or his/her designee.

Issuance of a Practical Division Range Key

To be eligible to receive a key to the Practical Range, you must complete all of the below items. After completing these, you may contact the Division Director and arrange for a range orientation.

Item 1: Participate in four (4) Practical Division sponsored matches: The matches MUST be either IDPA, USPSA, 1Gun, 2 Gun Action Match or ICORE. You must receive the match director's signature after shooting each match. To obtain the match director's signature, you MUST notify the match director prior to the match that you will need his/her signature so that the match director can either evaluate you or have another experienced shooter evaluate you. If you fail to notify the match director prior to the match starting, the match director will not be allowed to sign your certification for that match. Signing of this agreement by the match director is at the match director's discretion.
